- III. Commercial plots attract additional 20% of Land cost.
- IV. Corner piece plots attracts 10% of Land cost.
- V. Change /correction of name(s) attracts N10,000 charges (subject to review)
- VI. Transfer of ownership attracts 10% of land cost.
- VII. N.B: Non-payment of the monthly installments as at when due shall be treated as a fundamental breach of the contract which could result in termination or revocation of the contract/ OR attract a default charge of 10% of the monthly instalment payment.

When do I make other payments?

is there any time limit to commence my work on my land?

- No, but you are required to put a dwarf fence on land. Else, you pay N15,000 Horticulture fee yearly to make your land a green area pending the time your ready to develop the land.

Is there any restriction regarding the type of building I can construct in the estate

- Yes, The estate layout is in sections and you are limited to build houses on each section based on designated use or plan for that section. (Commercial or residential) i.e Bungalow, Block of flats \ Detached houses (duplex). Note , "Face-me -I- face you" (Tenement Houses) will not be permitted All building design must conform to the required set back of the building control of the estate and such design would be approved by the company with LSG afterwards.
